We undertake to pay attention to all circumstances stated hereby relating to the customs value and possible later changes and to announce these to Koch International in time before submission of the customs value registration. An affiliation within the meaning of Article 127 Union Customs Code Implementing Act [*UZK-Durchführungsrechtsakt*] does / does not exist (*).
4. We shall hand over all documents that are necessary for the customs clearance in an individual case to our authorised agent. This shall in particular include import permits, licences and valid proof of origin. Insofar as we would like to take advantage of customs preferences, we will hand over the necessary proof of preferences.

5. We will communicate the customs tariff number and the goods description separately in time. In case of non-availability of a customs tariff number we are obligated to determine this independently through the central information office for classification of tariffs in Dresden (Tel.: +49(0)351/44834520 or mail: info.gewerblich@zoll.de). We undertake to make binding customs tariff information available or that which is provided and issued to us at a later time available to the authorised agent without request as well as to inform the authorised agent in time if binding customs tariff information ceases to be valid.
6. Obligations according to foreign trade law are subject to our responsibility. Existing prohibitions and restrictions as well as other restrictions, in particular from customs law as well as international and/or political measures relating to international trade have been complied with.
7. We assume the sole responsibility for the completeness, accuracy and authenticity of all documents and details, which are necessary for the execution of the orders. Koch International neither has to verify, nor supplement this.
8. Koch International has the right to grant sub-powers of attorney.
9. We agree with the use and storage of our data for the purpose of the agreed contractual activities.
10. We are entitled / not entitled (*) to the full deduction of input tax for the goods that are to be registered

The ADSp 2017 limit in Subclause 23 the statutory liability for damages to goods according to Section 431 German Commercial Code [Handelsgesetzbuch - HGB] in the amount of 8.33 SDR/kg per damage case or for each damaging event to EUR 1 million or EUR 2 million or 2 SDR/kg, depending on which amount is higher and with multimodal transports under the inclusion of transport by sea generally to 2 SDR/kg.*
